

### **Mission Statement**


"Protection and Service of Our Citizens in a Professional and Compassionate Manner and the efficient and correct delivery of Law Enforcement services to the community."


In addition to patrol, the Sheriff's Office also serves civil papers, operates the county's 911 Emergency Communications Center and operates the county's jail.

## **Organizational Chart**





2014- 8,025 2015- 9,637 2016- 10,674 2017- 9,402


#### Number of Citations / Year



2014- 1,377 2015- 2,686 2016- 3,609 2017- 2,044





### **Communications Center Rennovation**



**Buena Vista County Communications** donated two adjustable, electronic consoles to the Ida County Sheriff's Office in early 2017. communications center was in need of a renovation to make it more efficient and effective given the huge changes that have taken place in technology in the last several years. Thanks to the donation by Buena Vista County, 2017 saw a major renovation which will last the Ida County Communications Center many, many years into the future.

The biggest improvement of this renovation is that the Communications Center now has two fully functional, customizable workstations, which allows two dispatchers to work in the center simultaneously. This is needed during times of inclement weather, high call volume, and during special events.



## K-9 Program Update



The Ida County Sheriff's Office has two K9s. The first is K9 Anou "Nu-Nu" who was purchased in May, 2014 and is handed by Deputy Andrew Shillington. Deputy Shillington is the K9 Unit Coordinator. Anou is a 6 year old Belgian Malanois that is trained in tracking ,area searches, building apprehension, criminal searches. narcotics detection, and evidence location/recovery. Anou is certified as a dual purpose patrol / narcotics dog through the United States Police Association. Canine Shillington is the K9 Unit Coordinator.

In 2017, the second K9, Nera, was Nera is a 2 year old purchased. female German Shepherd who is handled by Deputy Alex Ehlers. Nera is a single purpose canine trained in narcotics detection. Deputy Ehlers and Nera completed a 4 week basic handler's course at Mid-Michigan Kennels. Nera will be certifying through the United States Police canine Association in early 2018. information about the K9 program is available on our website.

## Jail Update

The Ida County Jail is staffed by one full time jailer, and supplemented by dispatchers that perform hourly checks. In the event of a problem in the jail, patrol deputies are called in from patrol to handle jail issues.

The Ida County Jail historically has a steady population of inmates.

Many inmates housed in the jail have concurrent substance abuse and mental health issues. The needs of the jail population have increased dramatically in the last several years as a side effect of a weakening mental health system within the state. Inmates require more constant monitoring.
